AGREEMENT TO STRUCTURE, POLICIES & PROCEDURES FOR 2010-2011

I have read, understand and agree to all Policies and Procedures as detailed in this document and understand that in the event the parent(s) fails to make any such payment in a timely manner as detailed in the Payment Plan Agreement form, the board reserves the right to limit the player's involvement with the team until payment is received in full. OVC will also refer a player to Cal South for "Financial Bad Standing" if their account is not current and all fees and interest have been not been paid in full by the end of September of the current playing year. Failure of OVC to exercise this option shall not constitute a waiver of the right to exercise it in the event of any subsequent default.

I also declare that all rules and regulations as set forth by OVC, Presidio League, Coast Soccer League, Cal South and USYSA shall be fully complied with by myself, my player/child, my entire family and any others whom I invite to any event in which OVC participates, including practices, games and tournaments.

I agree to pay all attorney fees and costs incurred by OVC in connection with the enforcement or collection of this agreement. I also agree to promptly return player's game jersey(s) at the end of the season or whenever the player leaves the team. If for whatever reason whatsoever I do not return the jersey(s), I agree to pay a \$65 uniform processing fee per unreturned jersey. I further understand that \$200 of my registration fees is non-refundable for any reason. **By signing the Affidavit of Compliance below, I agree to abide by the terms and conditions as stated within this agreement.**

If action is necessary, the available options range from a caution, to personal apology, reduced game playing time, probation, service work, suspension, or, as a final step, expulsion from the Club. As a member of the Oranje Voetbal Club, you are responsible for your own actions, and will be held accountable for them.
